Vat Refund for non resident in KSA

If you are a non-resident entity and you have suffered input VAT from the KSA vendors Zakat Tax and Custom Authority "ZATCA" are now allowing the refund under article 70 & 72 of the KSA VAT implementing regulations subject to fulfilling the following conditions as an eligible person.

- 1. The nonresident entity is VAT registered in the country of its origin.
- 2. The nonresident entity has not Fixed/Permanent Establishment in KSA
- 3. The country of non- resident entity has a tax reciprocity with KSA meaning the nonresident entity jurisdiction also allows VAT refund for KSA entities.

In order to claim the refund, the following steps need to be followed:

- 1. Register as an eligible person before 31 December of the calendar year of claim.
- 2. Prepare and submit your refund application before 30th June following the calendar year end. For example, for calendar year 2024 the refund application should be submitted before 30th June 2025;


